Duval County Ordinance 462.502.K-In addition to failure to initially license or renew a license, it shall be a distinct and separate violation of this section if the pet license is not acquired or renewed within five business days of vaccination or previous license expiration. This late renewal or licensing violation is subject to a fine of not less than the amount designated in [Chapter 462](#), Part 18. Service of these citations shall be via certified mail if the person is not present for hand delivery. Citations for violations of this section may be issued five business days following vaccination up to 45 calendar days at which time violations of [462.502\(a\)](#) shall be issued
