- **9.** Approval of a Settlement and Release Agreement with Waste Services of Florida, Inc. (WSI). WSI operated a franchise container services in Clay County

- under agreement No. 98/99-20, which required WSI to make payment of certain franchise fees to the county. After a recent audit, it was determined that WSI incorrectly calculated this payment and additional fees are due the county. WSI has a balance in their prepay account for tipping fees and a payment bond on file. Upon execution of this agreement those funds will be released to WSI. By entering into this settlement agreement, WSI shall pay the sum of \$81,080.88 to the county and the county shall make payment to WSI in the amount of \$16,133.35. This agreement shall act as a full settlement of all claims.
- **10.** Approval of modification #1 to Clay County Agreement 06/07-178, which is a Federally Funded Sub-Grant with the Division of Emergency Management (CERT). This modification will extend the expiration date of the grant funds to March 31, 2009, and increase the grant amount by \$1,500.00. The original amount of the grant was \$10,000.00.
- 11. Approval of contract with the City of Jacksonville for Medical Examiner services for Clay County for the period of October 1, 2008 through September 30, 2011. The Duval County Medical Examiner is appointed by the Governor to serve Nassau, Clay and Duval counties and this agreement is the Clay County portion of those services.
